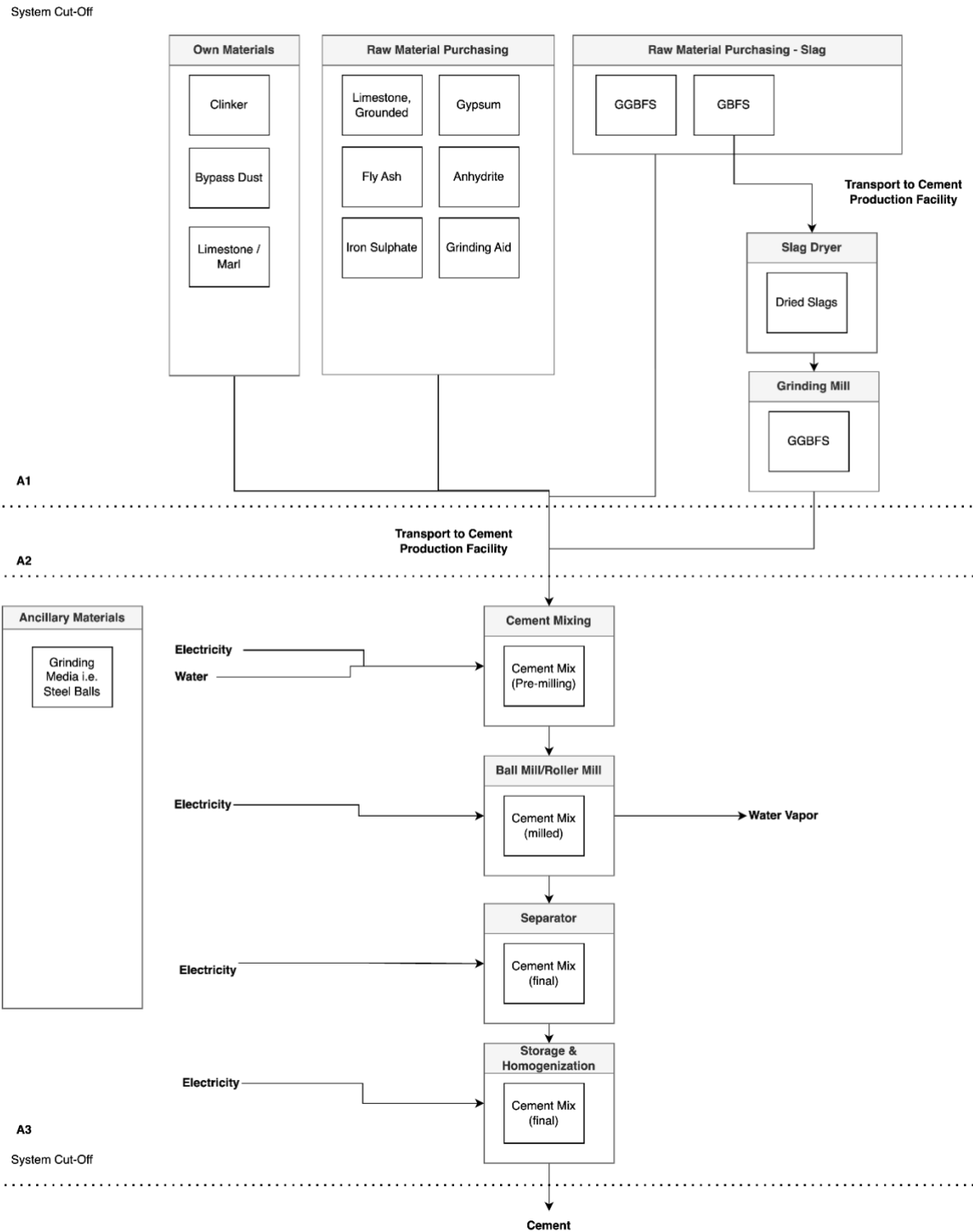

General Product Information

Cement is a hydraulic binder, mainly used for concrete, mortar and cement screed. Cement with specific properties is produced by intergrinding or blending Erwitte cement clinker, gypsum and other purchased materials like limestone. The origin of the Erwitte cement clinker used for the cement production is the Spenner plant Erwitte in Germany.
